## **Changes**

The organizer The Ink Lab B.inks reserves the right to change the dimensions of the exhibitor or tattoo artist. This does not give the exhibitor the right to withdraw from the contract. Changes to the program are reserved for the organizer!

## **Insurance**

The exhibitor is obligated to ensure adequate insurance coverage. The conclusion of an exhibitor insurance to cover the risk of transport and residency is recommended. Also for the liability of the individual stands, as well as personal items is to take care of itself! The organizer is not responsible for any liability!

**The organizer The Ink Lab B.inks bears the general liability risk for the event.**

## **Stand Design**

Floors, hall walls, columns, installation and fire protection equipment, as well as other solid hall installations, must not be covered, nailed, painted or otherwise damaged. Damages caused by the exhibitor will be charged. The technical guidelines of the Lünenseefabrik must also be observed.

## **Hygiene**

For hygiene reasons, there is a complete smoking ban in the entire Lünensee factory. Animals are not allowed! Every tattoo artist has to work according to the hygienic regulations of the country Austria, ie sterilized working materials, listed disinfectants, etc. Checks of the health office and the hygiene office are possible at any time.

## **Piercing**

Only authorized artists authorized by the organizer for piercing work are allowed throughout the event.

## **General**

- **It applies exclusively to the current, Austrian provision of the trade cosmetic restricted to tattooing! Each studio must have a valid business license. The organizer can not be held liable!**

- Young people under the age of 16 can not be tattooed without the right to education and their consent. Basically a tattoo is recommended from 18 years!
- The organizer accepts no liability for the executed tattoo work!
- Every exhibitor and tattoo artist is responsible for the cleanliness and hygiene of his stand and has to leave it clean!
- Every exhibitor is responsible for the duties to the responsible tax office.
- The arrangement of the organizer must be followed
- Claims against the organizer are to be made in writing within 4 weeks after the event, otherwise they are deemed to have been extinguished
- Services of the organizer can be found in the registration.
